AN UPDATE ON MEASURES BEING TAKEN TO PREVENT THE SPREAD OF COVID-19 BY MERCHANT SHIPPING – No. 128 07.03.2022

Further updates on COVID-19 precautions have been received from members as summarized below. As always, please contact the relevant association for more guidance.

Algeria	<p>All Algerian Ports are open to commercial operations both for import and export and applying recommended sanitary measures.</p> <p>Free pratique and start operations always subject to sanitary service green light.</p> <p>Local authorities require a list of documents to be sent 48 hrs. prior arrival or upon departure for short sea transit. This list includes IMO crew list, recent crew change list, crew temperature list, last 10 ports of call and medical declaration of health.</p> <p>Also, local authorities require a daily crew temperature list, until berthing of ships.</p> <p>Sailors who have embarked recently (During last 10 days before ship's arrival) must provide a negative PCR test certificate.</p> <p>Getting off to shore is not allowed for crewmembers, except in cases of force majeure, (sickness, serious issues etc).</p> <p>Crew changes are now allowed to be carried out at all Algerian ports provided that concerned crew present a complete COVID-19 vaccination certificate and an Antigen test of less than 72 hours.</p> <p>The boarding of the ship by the various control services (Border Police, Customs, Shipping Agents, Coast Guard, etc.) is reduced to the strict minimum.</p> <p>Personnel who handle and are in contact with ships (Dockers, pilots, shipping agents, Customs, etc.) are all protected by standard equipment.</p> <p>PASSENGER VESSELS ARE AUTHORIZED AGAIN: Passengers must comply with the following conditions:</p> <ul style="list-style-type: none">- Passengers of 18 years old and over must present proof of a complete vaccination containing a booster of the second dose at least 14 days before boarding.- Presentation of a negative PCR test certificate of less than 36 hours for all passengers over 12 years old, before boarding.- All passengers over 12 years old will be subjected to an Antigen test upon arrival to Algeria.
Argentina	<p>Update: 18th January 2022:</p> <p>In view of the epidemiological situation Argentina is currently going through, government promoted some changes on regulations regarding the requisites for foreigners to enter the national territory.</p> <p>Cross Border</p>

	<p>In this sense, it was determined that those operators of international passenger transports must verify the sanitary documentation exhibited at the time of boarding to corroborate compliance with all the sanitary requisites demanded.</p> <p>Therefore, passengers wishing to enter into the country, through the safe corridors authorized for this purpose, must submit:</p> <ol style="list-style-type: none"> (1) Affidavit required by the National Direction of Migration; (2) Negative PCR test performed in the country of origin within 72 hours prior to the beginning of the trip or medical discharge certificate issued within the last 90 days prior to the beginning of the trip together with the corresponding positive PCR; (3) Certificate providing vaccination scheme completed at least 14 days prior to the date of entrance to the national territory; and (4) COVID-19 health insurance. <p>Cruise Season</p> <p>With regards to the Antarctic and Bioceanic Cruise season, routine testing will not be required at the beginning or end of disembarkation for shore excursions, but will be required for the final disembarkation of the trip.</p> <p>In the event of a positive case on board, the tests will be sent for sequencing and quarantine of vessel and isolation of passengers will be kept until the results of such sequencing are obtained.</p> <p>If sequencing results confirm Omicron variant, isolation will be maintained following the recommendations of the national sanitary authority and no passenger shall disembark.</p> <p>International Crew Changes</p> <p>International maritime crew changes are allowed as long as both migratory and sanitary requirements in force at the time of the relief are complied, including complete vaccination scheme.</p> <p>Crew changes shall be allowed only in ports that have a provincial jurisdictional protocol or one of the Autonomous City of Buenos Aires, for referral, medical attention and sanitary transfer, or according to the case of testing and genomic sequencing, previously presented to and validated by the Undersecretary of Ports, Navigable Waterways and Merchant Marine.</p>
<p>Australia</p>	<p>The crew change situation in Australia remains complicated by differing Federal and state limitations, as well as rapid changes to policies. Shipping Australia have therefore issued the following guidance on their website:</p> <p>“Seafarers and crew change managers booking flights to Australia may wish to carefully think about their travel plans prior to booking.</p> <p>Travel to Australia remains difficult. Australia has severe and short limits on the numbers of people - even including its own citizens - it will allow into the country each week.</p> <p>Travel within Australia can be extremely difficult or, alternatively, easy. Whether it is difficult or easy is completely dependent on the situation at the time. NOTE: the rules are extremely fluid and can change at any time. For instance, there are numerous examples of people being caught-out on the wrong side of a border after travel restrictions have been announced. Those people were then stuck for days, weeks and</p>

	<p>months. There have also been instances where plane-loads of passengers have taken off, only for the rules to change mid-flight and the passengers were then forced into quarantine (or sent home) upon arrival at their destination.</p> <p>Queensland, however, remains the easiest jurisdiction in which to carry out crew changes in Australia”.</p> <p>The SAL website (www.shippingaustralia.com.au/covid-19-shipping-update) is regularly updated with detailed information on crew changes and the current Federal and state restrictions.</p>
Belgium	<p>The major Belgian ports of Antwerp, Bruges, Ghent, Ostend and Zeebrugge are now offering the Johnson and Johnson one-shot vaccine to foreign seafarers, regardless of nationality, arriving in Belgium as either a current crew member or an on or off-signer.</p> <p>In those ports, vaccinations are provided by a mobile unit that visits the vessels, rather than requiring the crew members to travel to a centre ashore, as elsewhere. Further information on the programme and the processes for booking vaccination visits can be obtained by contacting the local agent or through NAVES, hilde.bruggeman@naves.be</p>
Brazil	<p>Some states have declared a 14-day lockdown since most cities has now reached full hospital intensive care capacity. The beginning of this period can vary as decided by each State but, in general, it should happen during the 2nd half of March.</p> <p>At present, and despite of adverse situation, the Brazilian ports are still maintaining their regular loading and unloading cargo operations, as well as the crew change arrangements considering the precautions recommended by IMO. The situation may change at any time and a more aggressive level of restrictive measures could be adopted, thereby affecting a foreign trade chain and specifically a movement of cargo and crew change in Brazilian ports. We will provide updates as the situation changes.</p>
Cabo Verde	<p>We have been able to secure the green light from Cabo Verde Health Authorities to offer vaccination to any seafarers of any nationality that call Mindelo. Due to their good diplomatic relations, we expect the quantity of vaccines available at this stage is more than enough for the local population in Cabo Verde, hence their agreement to assist this urgent issue for the international shipping community.</p> <p>The vaccines are available both to vessels calling Mindelo for cargo operations but also for those who decide to have a “vaccination only” call. In close coordination with health authorities, we will adopt following procedure:</p> <ul style="list-style-type: none"> - Request to be made to the agent 10 days before intended vessel call - Health Authorities will confirm vaccines available within 3 working days - Port call to be done on standard procedure (clearance, standard costs, agency fee, etc.). Same to be done on anchorage or at berth, subject to owner preference and berth availability - We will arrange vaccination on board OR crew to come to vaccination centre in 2 groups. - Service fee applicable depending on number of crew members to be vaccinated. <p>Health authorities expect vaccine to be Astra Zeneca and they are available to:</p> <ul style="list-style-type: none"> - Give two doses if vessel calls Cabo Verde within the period (or stays for 4 weeks) - Give dose number one

	<p>- Give dose number two</p> <p>Although small, we believe this is an important step to contribute to ease restrictions on crew changes and improve live and work conditions to seafarers.</p>
<p>Chile</p>	<p>Please find restrictions to be followed by non-residents entering to Chile as from today December 1st 2021. Same were reported by Authorities to be applied as from yesterday at 00:00 hrs LT. This is a free translation of document published in internet by Health Authority on last Tuesday.</p> <p>ENTRANCE TO CHILE</p> <p>Who can enter Chile?</p> <ul style="list-style-type: none"> • All non-resident foreigners in Chile (tourists) who have a Chilean Mobility Pass, which is the coronavirus vaccination certificate. Vaccines received abroad must have been previously validated in Chile to obtain it. (Paperwork should be performed in advance, it could take about 2-3 weeks). • Non-resident foreigners in Chile (tourists) under 6 years of age who have not been able to access vaccination against coronavirus, without need of Chilean Mobility Pass. • Foreigners not resident in Chile who comply with any of the exceptions contained in Decree 295 of the Ministry of the Interior. <p>The entry of foreigners without regular residence who have been in the following countries of Africa in the last 14 days IS PROHIBITED: South Africa, Zimbabwe, Namibia, Botswana, Lesotho, Eswatini, Mozambique</p> <p>To any foreigner without regular residence over 6 years of age who is not vaccinated or who does not have his vaccination previously validated by the Ministry of Health of Chile, and who does not comply with any of the exceptions contained in Decree 295 of the Ministry of the Interior.</p> <p>Border crossings enabled for entry into the country</p> <p>Arturo Merino Benítez Airport Iquique Airport Antofagasta Airport Punta Arenas Airport</p> <p>Who can leave Chile?</p> <p>All, without any restrictions and without the need for a Virtual Police Station permit or Mobility Pass.</p> <p>Border crossings enabled for exit from the country:</p> <p>Arturo Merino Benítez Airport Iquique Airport Antofagasta Airport Punta Arenas Airport</p> <p>SANITARY MEASURES WHEN ENTERING CHILE</p> <ul style="list-style-type: none"> • PCR Negative taken in the country of origin with 72hrs. before boarding the airplane (from 2 years of age. Children under 2 years of age are exempt from this requirement). • Affidavit from the c19.cl website.

- Medical insurance US\$ 30.000 dollars to cover diseases associated with COVID-19. (In the case of citizens of Spanish nationality, point IV number 28 of Exempt Resolution 672 applies, which indicates that this insurance will not be required).
- Validation of vaccine approved by the Ministry of Health.

These documents will be required by the operator of the means of transport when boarding , and by the Health authority when entering the country.

Those who have a complete vaccination schedule validated by the Ministry of Health:

- Upon entering the country, you will be screened for coronavirus (PCR).
- You must quarantine at an address reported in the Affidavit, until you receive the negative test result.

To get to this place, domestic flight connections are allowed, even if you have not yet received the negative result of the coronavirus test made at the entrance.

Once the Ministry of Health receives the negative result of the test from the laboratory, the mobility pass will be enabled.

Those who are under 6 years old, who have not been able to access vaccination for coronavirus and travel with a father, mother or legal guardian with a complete vaccination schedule validated by the Ministry of Health:

Children between 2 and 6 years old who enter the country with their father, mother or legal guardian who if they have a complete vaccination schedule validated, upon entry into the country. They will be screened for coronavirus (PCR). Until you receive the negative result of this test, you must quarantine at an address reported in the Affidavit.

To get to this place, domestic flight connections are allowed, even if you have not yet received the negative result of the coronavirus test made at the entrance.

Children under two years of age who enter the country with their father, mother or legal guardian who do have a complete validated vaccination schedule. They will be able to enter the country fulfilling the same conditions as their father, mother or legal guardian, but without the need to take PCR upon admission.

Those who are not vaccinated or do not have a complete vaccination schedule validated by the Ministry of Health:

This alternative is available only to non-resident foreigners who comply with any exception listed in Decree 295 of 2021 of the Ministry of the Interior:

At the point of entry into the country you will be tested for coronavirus (PCR).

They must perform 168 hours (7 days) of quarantine, counted from the sanitary control at the point of entry into the country.

A negative result of the coronavirus test carried out at the point of entry into the country, does NOT allow the quarantine period to end in advance.

Transfer requirements

They must arrive at the declared address in private transport and directly from the entrance to the country without the possibility of spending the night or interacting with other people.

Collective means of public transport including trains, buses and planes may not be used.

Transfer by minor public transport (taxis) or the use of private transfer companies working at airports is allowed. In this case, you can only share a vehicle with the same group with which you travelled.

	<p>In the event that the place of quarantine is more than two hours from the point of entry into the country, the driver of the means of transport must isolate himself for the same days.</p> <p>During quarantine, the traveller and their cohabitants may NOT:</p> <ul style="list-style-type: none"> • Leave the home • Leave the hotel room (in case it is voluntarily decided to carry out isolation in a hotel). • Receive visitors • Go out for a walk pets • Going out to work • Attend educational establishments • Use public transport • Use a health passport or mobility pass <p>14-day Traveller Tracking</p> <ul style="list-style-type: none"> • Self-report: Anyone entering the country must complete a symptom self-report form for 14 days, where they must complete a health status and location survey. • Testing: The traveller may be subjected to one or more diagnostic tests for COVID-19, either at the same point of entry into the country or in any of the following 14 days. Diagnostic tests can be PCR and/or antigen tests. They may also be subjected to genotyping studies. • Control: Travelers who are complying with quarantine will be inspected in person at the place declared for compliance with it, on any day and time during the quarantine.
Cyprus	<p>By means of Circular 27/2021, Cyprus has made some stocks of EMA-approved vaccines available to seafarers serving on board ships which are:</p> <ol style="list-style-type: none"> 1. <i>flying the flag of Cyprus; and</i> 2. <i>are managed by a legal entity based and taxed in Cyprus, if the ship in question calls at a Cyprus port, anchorages or roadstead located in the territory of Cyprus.</i> <p>Further information can be found on the Circular that is available here:</p>
Denmark	<p>Update: All restrictions against cruise vessels will be lifted on 1st February 2022, at which time all cruise passengers will be treated like any other traveller.</p> <p>Denmark will also acknowledge non-EU approved vaccines for travellers in accordance with WHO guidelines, e.g. Sinopharm.</p> <p>The vast majority of restrictions in Denmark will be lifted as from 1st February 2022.</p>
Dubai	<p>The authorities have now introduced the UAE Maritime Activities Return to Work Safely Protocol. The Protocol takes into prospective the following overarching principles:</p> <ol style="list-style-type: none"> 1. Adhere to public health requirements and precautionary measures in the UAE for maritime workers and those involved in marine activities. 2. Pre-registration of crew members' itinerary to join ships or return home. 3. Crew members' self-monitoring of traveler's health, in addition to knowledge of precautionary instructions and procedures, starting and during travel. 4. A Maritime Declaration of Health (according to the model of the WHO) and a pledge by the captain of the ship regarding the absence of any contagious diseases.

	<p>5. Any other mandatory requirements issued that require adherence, before departure or when ships come to ports or dry docks within UAE, or when conducting marine activities.</p> <p>6. A designated person in every port and dry dock facility to follow up on all issues related to the prevention of COVID-19 pandemic and submit an internal daily report in order to review the procedures and to continuously improve them.</p> <p>1. Crew change procedures. Crew change is permitted in the UAE ports and waters, taking into considerations the following:</p> <p>1.1 Signing-on: - Obtain a seafarer entry visa (96 hours' visa). - The compulsory laboratory test for all seafarers wishing to enter the country without any exemption. The shipping agent should bear the responsibility to return the seafarer to his ship or provide a safe medical shelter if the COVID test was positive in accordance with the required instructions imposed by the health authorities in UAE.</p> <p>1.2 Signing-off: - Provide the port authority with the Maritime Declaration of Health confirming the crew are free from any symptoms or epidemics, subject to penalties in force in the UAE in the event of presenting an incorrect health declaration report.</p> <ul style="list-style-type: none"> - Provide the immigration office in the port with a copy of the same above mentioned declaration. - Obtain confirmed flight booking (Departure Ticket) on the nearest available flight. - Obtain a seafarer entry visa (96 hours' visa). - The seafarer should go through the required COVID 19 test as specified by the UAE health authorities. - in case of Positive result of the test, the shipping agent should follow the required instructions applied by the competent authorities <p>2. Dry Docks and Ship Repairs Facilities Procedures</p> <ol style="list-style-type: none"> 1. Provide dry docks and ship repair facilities with the Maritime Declaration of Health, that seafarers are free of any infectious diseases or epidemics before accepting the vessel. 2. Dry docks and ship repair facilities measure seafarers' temperatures on a daily basis until their departure, in anticipation of any Covid-19 cases. 3. Restrict seafarers' movement around to prevent unnecessary contact in the docks and maintenance workshops 4. Appoint a designated person by the dry dock or the ship repairs facilities to record the names of the supervisors and their employees on a daily basis those who are in charge of the maintenance of the ship, in order to facilitate the information of those in contact with the suspected cases on the ship later. 5. Follow all required isolation procedures on the ship in the event that there is a suspected case of Covid-19 or any other contagious diseases, and promptly inform the concerned health authorities. <p>3. Ships and Off-Shore Supply Vessels Procedures</p> <ol style="list-style-type: none"> 1. Request a Maritime Declaration of Health (according to the model provided by the WHO) and a pledge by the captain that confirms the vessel is free of any contagious diseases, as an alternative for the requirements for any tests. 2. Imposing quarantine on ships and marine units suspected of having symptoms of infectious diseases or any epidemics between their crew. The suspected ship or marine

	<p>unit is not allowed to carry out any operations in UAE waters and ports except after going through the required tests as specified by the UAE health authorities.</p> <p>3. Resume issuing Entry and Exit visas for seafarers with residence permits, who are working on national or foreign ships and off shore supply vessels which has a navigation license in the UAE, to ensure facilitation of its business and its transportation inside and outside the UAE.</p> <p>4. Passenger Ships Procedures</p> <p>1. Maintain prohibiting Passenger ships from calling and docking in UAE waters and ports.</p> <p>2. Maintain prohibiting Passenger ships already docked at UAE ports from conducting any activity whatsoever.</p> <p>5. Ferries Procedures</p> <p>Continue to prohibit any passenger ferries activity at the present time in UAE waters and ports, with the exception of deporting the stranded passengers only, and after taking the necessary approvals from the local authorities in the UAE and the concerned embassies to ensure the smooth reception of them in the country of arrival.</p> <p>6. Wooden Ships (Dhows) Procedures</p> <p>Maintain existing procedures to prevent wooden ships (Dhows) from staying for more than 7 days, and not to receive the ships without confirming the presence of goods ready to be transported, in order to reduce the period of their stay in UAE waters.</p> <p>7. Yachts and Leisure Boats Procedures</p> <p>1. Lift the restrictions on the use of leisure boats, yachts, commercial charter, pleasure and touring activities, taking into consideration adhering to the approved capacity of 50% of the actual vessel capacity at this stage, and complying with the approved health guidelines and using the personal protective equipment.</p> <p>2. Allow visiting foreign flag yachts to call UAE waters, ports and marinas, and resume issuing the sailing permit for them by the Federal Transport Authority –Land & Maritime, so long as they present Maritime Declaration of Health (according to the model provided by World Health Organization) confirming that the crew are free from any symptoms or contagious diseases before arriving at the first point of entry in the UAE, subject to the penalties in force in the UAE in the event of presenting an incorrect health declaration report.</p> <p>3. Restrict the use of the Jet ski by its rider only, without allowing additional passenger.</p> <p>8. Shore Passes Procedures</p> <p>1. Suspend the 24 hours' shore passes (permits to visit the city), with possible exception for seafarers on board yachts, recreational boats and ships which has been in the country for a period of more than 14 days, provided that they comply with the enforced health requirements in the UAE.</p> <p>2. The agent should provide the seafarers with all Covid-19 pandemic relevant laws and precautionary measures followed in the UAE and the importance of adhering to them, in addition he should provide them with the information related to the penalties imposed in case of violation, he should document their acknowledgment of receiving theses information from him.</p>

	<p>3. The port should measure seafarer's temperature before authorizing them to leave the port gate as a precautionary measure to monitor any symptoms that may indicate infection with Covid-19. 9. Protocol Review and Update Mechanism In coordination with the concerned entities in the UAE, the competent authorities will review and update the protocol periodically and when needed in the event of substantial developments in the Covid-19 pandemic procedures.</p>
Egypt	<p>The following advice has just been released by the Egyptian health authorities:</p> <p>Kindly be informed and act accordingly with the necessary for quarantine at airports, seaports and crossing points regarding the update of the regulations, prescribed health measures & formalities regarding the vaccine against coronavirus and the requirement of having a coronavirus vaccine certificate as follows:</p> <p>Arrivals with coronavirus vaccine certificate:</p> <ul style="list-style-type: none"> • Arrivals who have a vaccine certificate against coronavirus from countries affected by strains of coronavirus at India, Bangladesh, Pakistan, Bhutan , Myanmar, Nepal, Sri Lanka, Vietnam, Brazil, Latin America: The following will be applied: <ol style="list-style-type: none"> 1. Revising the vaccine certificate against coronavirus with the arrivals and accepting the approved certificates in the country of issuance without scraping or adding any wording to the certificate, also the certificate must be with the QR Code, only then it will be accepted after making sure of place of issuance of the certificates. 2. Making ID NOW COVID-19 test analysis and in case being positive, a PCR test will be carried at destination of arrival and in case of being positive the arrival will be sent to fever hospital to take the necessary protocol. 3. Arrival with the vaccine certificate against coronavirus from countries not affected with strains of coronavirus directly or indirectly during the past 14 days, the certificate will be approved after being revised with the country of issue and the certificate must be without scraping or any additional notes and it also must include the QR Code. • The vaccines approved by the International Health Organization, and Egyptian Medicine Authority are accepted taking into consideration that 14 days must pass the date of the 2nd dose of the vaccine for vaccines given on 2 doses (Pfizer, AstraZeneca, Moderna, Sinopharm, Sinovac, Sputnik) or 14 days to pass the date of having the first dose of Jonsen & Jonsen vaccine. <p>Arrival without a coronavirus vaccine certificate:</p> <p>They must follow the rules and health measures taken in that regard in view of the decision taken by prime Minister and in related circulars.</p>
Finland	<p>See the advice on crew changes (and other travel arrangements), previously circulated under update no. 78.</p>
Germany	<p>Free vaccinations are available for foreign seafarers in almost all German ports. Please contact your local agents or owners' representative for further details and for organizing an appointment on shore.</p> <p>Seafarers vaccinated with Sputnik or Sinovac or other unauthorised vaccines are considered as "unvaccinated". However, also those seafarers can receive vaccination with approved vaccines.</p>

	<p>The national vaccination programme is open to foreign seafarers. In the ports of Bremen, Bremerhaven and Hamburg there are exclusive vaccination appointments for foreign seafarers.</p> <p>Crew changes are still possible. Call your local agents for further details</p>
<p>Great Britain</p>	<p>Full details of the current COVID measures can be found at: www.gov.uk/coronavirus. Please note that there are some variations in measures across England, Scotland, Wales, and Northern Ireland so care should be taken to check the correct measures. Some of the measures may change in the next two weeks so a check of the up-to-date information via the agent is recommended before organising any crew changes</p> <p>All UK ports are operating normally, and seafarers are free to go ashore.</p> <p>The following is a summary of the measures for seafarers, inspectors and surveyors arriving at ports in England:</p> <p>Before travel to England</p> <p>You do not need to complete the passenger locator form if you are travelling by maritime vessel to England for purposes of work or for repatriation.</p> <p>You do need to complete the passenger locator form if you are travelling to England via plane or train.</p> <p>You do not need to take a COVID-19 test before you travel to England if you are a seafarer or fisherman, inspector, or surveyor of ships due to work on a vessel or need to transit the UK to join or leave a vessel. You should show a valid SID if you have one.</p> <p>After arrival in England:</p> <p>If fully vaccinated</p> <p>You do not need to quarantine.</p> <p>You must take a lateral flow device (LFD) test on or before day 2. If you are travelling internationally on a daily basis, you need to take an LFD test every 3 days.</p> <p>If not fully vaccinated</p> <p>If you are in England for more than 2 days, you are required to take a lateral flow device (LFD) test on days 2, 5 and 8.</p> <p>Constant travellers who enter and leave England on a daily basis, or at intervals of no greater than 2 days should undertake an LFT at least once every 3 days.</p> <p>LFTs can be accessed and made available at the workplace, in the community or at home.</p> <p>If you live in the UK you do not need to quarantine.</p> <p>If you live overseas you must quarantine in the place you are staying for 10 days while in England, except while you are undertaking the exempt activity or travelling as part of your work.</p> <p>Red List countries: There are currently no countries on the UK Red List</p> <p>Evidence</p> <p>If you work on a ship, including fishermen, you should show a Seafarer’s Identification Document (SID) if you have one.</p>

	<p>If you don't have a SID, you can show your joining papers, seafarer's employment agreement or a seafarer's discharge book (Continuous Certificate of Discharge) instead. DECREE OF THE PRESIDENT OF THE CABINET - 14 January 2021

Art. 9

Obligations of carriers and shipowners

1. Carriers and shipowners are required to:

- a) acquire and verify before boarding the declaration referred to in art. 7;
- b) check the body temperature of each passengers;
- c) prohibit boarding for those who are or have been feverish, as well as who have not completed the declaration referred to in (a);
- d) adopt all measures which, in accordance with the "Shared Regulatory Protocol to contain the spread of COVID-19 in transport and logistics sector" signed on 20 March 2020, as referred to in Annex 14, "Organizational arrangements to contain the spread of COVID-19 in the field of public transport" referred to in Annex 15, and ensure at all times of the journey an interpersonal distance of at least one meter between the passengers transported;
- e) make sure that the crew and passengers use personal protective equipment and to indicate situations in which they may be temporarily and exceptionally removed;
- f) supply at the time of embarkation, passengers who do not have the means of personal protection with same.

2. In exceptional cases and, in any case, only in the presence of requirements for the protection of Italian citizens abroad and the fulfilment of international and European obligations, including those arising from the implementation of Council Directive (EU) 2015/637 of 20 April 2015, "On coordination and cooperation measures to facilitate consular protection of Union citizens not represented in third countries" and repealing Decision 95/553/EC, by decree of the Ministry for Infrastructure and Transport, adopted on a proposal from the Ministry for Foreign Affairs and International Cooperation and in agreement with the Ministry for Health, specific and temporary derogations from the provisions of this Article may be provided.

Art.10

Provisions on cruise ships and foreign flag ships

1. Cruise services by Italian flag passenger ships may be carried out only in compliance with the specific guidelines set out in Annex 17 to this Decree, validated by the Technical and Scientific Committee referred to in art. 2 of Order No 630 of 3 February 2020 of the Head of the Department of Civil Protection.

2. Cruise services may be used by those who are not subject to or obliged to comply with health surveillance and/or fiduciary isolation measures and who have not been during the fourteen days prior to embarkation in the States or territories listed in Lists D and E of Annex 20. In case of residence or transit in states or territories listed in List C, the Article 8, paragraph 6 will be applied.

	<p>3. For the purpose of authorizing the cruise to take place, before the departure of the vessel, the Master shall submit to the Maritime Authority a specific declaration where following points will be stated:</p> <p>a) the preparation of all the measures necessary to comply with the guidelines referred to in paragraph 1;</p> <p>b) the subsequent ports of call and the port at the end of the cruise, with the relevant arrival/departure dates;</p> <p>c) the nationality and origin of the passengers on board in compliance with the provisions referred to in the preceding subparagraph.</p> <p>4. A. Cruise Ships

1. Procedures are required from the shipping agent 24 hours before the ship arrives at the port of Aqaba:
 - a) Providing the lists of passengers (Manifest) to Jordan Maritime Commission.
 - b) In case of restricted nationalities (the passengers), the shipping agent is responsible for ensuring that the concerned passengers obtain the necessary approvals from the competent authorities.
 - c) Fill out the health form of Jordan Maritime Commission stating that the tourists and crew are clear of any disease symptoms, and report any case on the ship, if any.
2. The following are required for the traveler to enter the Kingdom:
 - a) It is preferable to have a vaccine certificate that shows receiving the full doses of the vaccine.
 - b) No need PCR test for all arrivals to aqaba port.
 - c) the passengers or crew and they wish to go to land, they don't need p.c.r test.

3. The shipping agent writes a pledge to Jordan Maritime Commission to implement all public safety procedures, as well as ensure the accuracy of vaccination certificates, if any, In addition, pledging provides all infection prevention equipment (sterilization materials, masks, gloves and hygiene in general) and adheres to Ship crews and tourists to wear protective equipment, the most important of which (masks and gloves). Moreover, to carry out sterilization operations constantly.
4. The shipping agent undertakes to report any infection with the Coronavirus onboard the ship and should be isolated in rooms designated for this inside the ship, with all necessary treatments and respirators available.
5. The shipping agent undertakes to bear the financial and administrative responsibilities in terms of transportation, treatment or deportation concerning any person from the tourists or the crew of the ship who is infected with Coronavirus and bears the legal responsibility in case of breach of the pledging.
6. The committee consisting of (Jordan Maritime Commission, the Public Security Directorate, the General Intelligence Department, the Navy and Royal Yachts, the General Customs Department) continues its work as it was previously. Further, the shipping agent should ensure the sterilization of the ship from the licensed companies to the places where the committee is existed on board the ship when boarding the ship and sterilizing the ways in which the marine guide walks in the ship.
7. The Aqaba Governorate Health Directorate should send a representative to supervise the process of disembarking the passengers and to ensure the implementation of public safety measures that prevent the spread of the Coronavirus, in addition to conducting a temperature check for passengers upon disembarking from the ship.
8. A designated tourist police force should escort the buses/tourist cars that transport the passengers to the specified visit destination, provided that they are committed to staying with them until they return to the ship.
9. The Ministry of Tourism, Tourism Promotion Commission, Aqaba Special Economic Zone Authority, and Petra Regional Authority, according to the jurisdiction area, shall ensure that public safety procedures are applied. Moreover, notify the Jordan Maritime Commission of any violations in this regard to imposing the necessary fine on the shipping agent per the pledge made by her signature.

10. If the crews of cruise ships have willing to enter the Kingdom, the following conditions shall apply to them, according to the destination of entry:
- a. **Entry to the city of Aqaba:** A request grants a land visit permit granted by the Directorate of Residence and Borders and according to the laws regulating this. Moreover, the same health conditions that were requested from travelers previously apply to them.
 - b. **Entering the direction of Petra or Wadi Rum, or travelling outside the country by air:** The usual procedures for the Residence and Borders Law are applied in terms of stamping the passport and the necessary pledges. Moreover, the same health conditions that were requested for travelers previously apply to them.
11. Tour guides, as well as bus/tourist car drivers, are required to obtain a certificate of receiving the full doses of the vaccine.
12. It is required that any person connected with the ship in terms of supplying or maintaining obtain a certificate of receiving the full doses of the vaccine.
13. Aqaba Special Economic Zone Authority, Jordan Maritime Commission, the Navy and the Royal Yachts, the Aqaba Health Directorate, and the concerned bodies mentioned above in point (9) are obligated to control and monitor all established health protocols.

B. Tourist/Private Boats/Yachts

1. The following areas are considered departure points for private/tourist boat trips.
 - a. The Royal Yacht Club.
 - b. Tala bay.
 - c. Ayla after completing the duly approved procedures.
2. Passengers who obtained a full-dose vaccination certificate (14) days before travel and possessed allowed to return to Jordan without a p.c.r test at the point of return.
3. The Aqaba Governorate Health Directorate will send a representative to supervise the process of boarding and disembarking passengers and to ensure that public safety measures are applied to prevent the spread of the Coronavirus. In addition, conducting a temperature check for passengers when they disembark from the boat.

4. The committee consisting of (Jordan Maritime Commission, the Public Security Directorate, the General Intelligence Department, the Royal Navy and Royal Boats, and the General Customs Department) continues its work as it was previously.
5. It is required that the cadres and crews working on tourist boats obtain a certificate of vaccination with full doses as the main condition for work.
6. The shipping agent undertakes to provide all equipment to prevent the transmission of infection (sterilization materials, masks, gloves and hygiene in general) and ships crews and tourists are restricted to wearing protective equipment, the most important of which is (masks and gloves), and to carry out sterilization operations constantly.
7. It is required that any person connected with the boats in terms of supplying or maintaining have received a certificate of full-dose vaccination.
8. Aqaba Special Economic Zone Authority, Jordan Maritime Commission, Navy and the Royal Yachts, are obligated to control and monitor all established health protocols.

C. Merchant Ship Crews:

1. The crews should obtain a certificate of vaccination with full doses.
2. The shipping agent should inform the Jordan Maritime Commission of the crews' desire to disembark from the ship to Aqaba City after verifying the full dose vaccination certificates if any.
3. Jordan Maritime Commission grants the crews approval to join the ships and disembark after obtaining the approval of the Public Security Directorate and under the national regulating laws and verifying the certificates of vaccination with complete doses, if any.
4. Crew transit passengers who wish to stay at a hotel until their travels must obtain approval from Jordan Maritime Commission, in coordination with the Public Security Directorate, and under the national laws governing this.
5. The shipping agent is obligated to take the maximum levels of public safety procedures for crews while roaming in the city of Aqaba.

6. Aqaba Special Economic Zone Authority, Jordan Maritime Commission, the Navy and the Royal Yachts are obligated to monitor all established health protocols.

D. General procedures to be taken into account by the ship agents and the concerned regulatory authorities mentioned in this protocol:

1. General health procedures before starting the operation:
 - a. Sterilizing the entire marine unit, equipment and tools, in coordination with the Directorate of Health, to use the appropriate materials to be used in the sterilization process.
 - b. Providing hand sanitizers and other sanitizers at different places within the marine unit.
 - c. Designating a health observer within the marine unit to ensure compliance of crew and passengers with health protocols and public safety procedures.
 - d. Obligating the crew inside the marine unit to continuously sterilize their hands, wear a mask, and replace it on an ongoing basis as soon as it is contaminated.
 - e. Ensure the safety of crews and that they are not infected with any of the symptoms of the Coronavirus before the departure of the ship.
 - f. The crew shall wash their hands thoroughly before touching equipment to prepare it for use.
 - g. Providing good ventilation inside the marine unit.
2. General health procedures during operation:
 - a. Taking into account the physical distance in arranging seating places and tables, at least two meters.
 - b. Organizing the process of boarding and disembarking for passengers, taking into account the physical distance between visitors of less than two meters.
 - c. Requiring passengers to wear masks throughout the flight and to provide hand sanitizers in places.
 - d. Any kind of party on board the tourist boat is prohibited.
 - e. Banning the open buffet service on tourist trips on boats and relying on ordered customized menus.

- f. Using disposable eating utensils as much as possible, placing sterilization kits and napkins on each dining table, and placing awareness instructions throughout the marine unit.
 - g. Staff who prepare food must adhere to personal protective equipment such as masks, frequent hand washing (replace the mask immediately after contamination or moisture), head covering, beard cover, food safety shoes (the type that does not affect food), as well as work clothes.
 - h. Continuous sterilization of all ship facilities, especially areas used by passengers, regularly.
 - i. Putting warning signs on board the boat that obligates all staff and facilities to continuously sterilize, distance, wear masks and wash hands
3. A periodic inspection should be carried out by the concerned cadres Aqaba Special Economic Zone Authority and in coordination with Jordan Maritime Commission, health directorates and the competent authorities.
