New ConTex-Commentary - issued:

20.04.17

Overall the New ConTex continued it's upward trend reflecting the improved charter hires and periods. Based on strong cargo volumes the demand for Panamax units remains healthy and the 3500 TEU segment has benefited recently from the dwindling supply of larger vessels. Here the catching up has led to improvements of \$ 209 (+ 2,3%) within the last week.

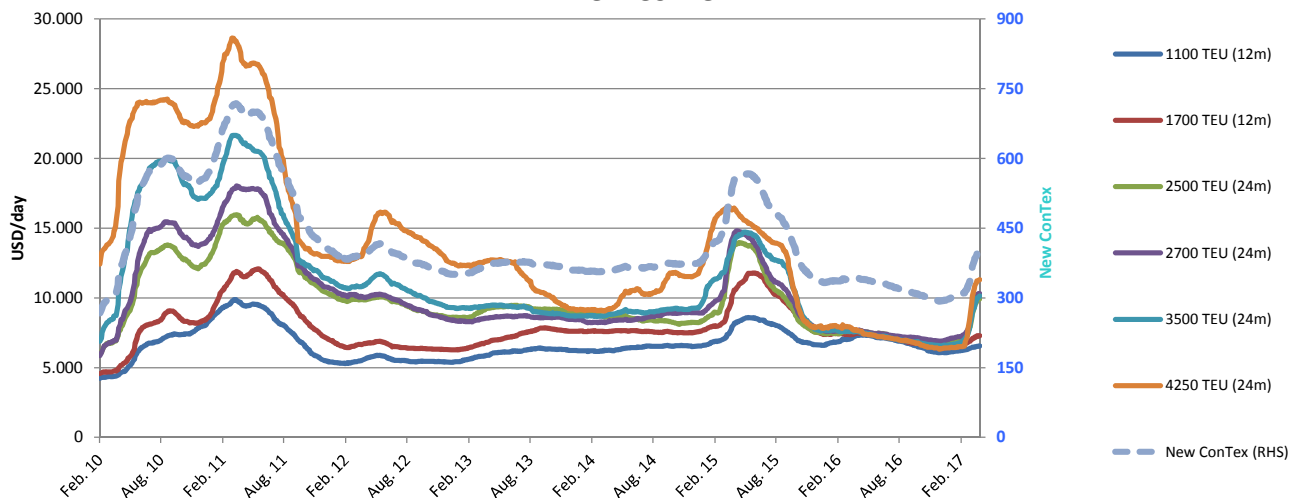
The smaller sizes (1100 and 1700 TEU) have not seen the dramatic rise in hires yet, but the sentiment is positive and if the silver linings on the horizon turn into healthy demand, then there is no reason why the feeder segments should stay behind.

Let us remind ourselves that Baby-Panamax ships have moved from \$ 4,500 to \$ 10,500 within 6 weeks only. In the same time frame the 1100 TEU segment gained around \$ 300 while the 1700 TEU segment climbed by about \$ 600. The Easter holidays certainly dampened activities, but week 16 has brought increased activity below 2000 TEU.
