
The New ConTex showed another downward trend through all sizes within the third week of decreasing fixtures being concluded. The smaller segment of 1100 and 1700 TEU, being the most steady size within this week with a change of only -0.4% on the W-o-W basis.

The 2700's and the 3500's also managed to repel the downward trend with only -0.5% and -1.1% W-o-W compared to the 2500's which went down -2.9%.

The Panamax segment got a strong hit by -6.1% as the (still) existing overcapacity within the segment is giving Owners the incentive to accept lower rates with the fear of having to compensate too much idling time. Owners honored prompt delivery with a good rebate on the rate.

It is hard to predict the coming weeks as there is still a number of fixtures being concluded and if this continues, it could well be that there will be shortages in some segments/areas which could indeed help to at least sustain current market levels.
