## New ConTex-Commentary - issued:

27.07.17


With just one point less (equal to -0,3%) the New ConTex ends this week with a level of 380 points. For the full index this is about 1/6 more than last year at the same time. Except for the 12 months evaluations of the feeder classes of 1,100 resp. 1,700 TEU, every single class reads a marginal negative sideways trend, except for the Baby Panamaxes, which suffered further ground losses during the past evaluations and are today reading USD 8.646,- for the 24 months evaluation respectively USD 7.144,- for the 12 months evaluation respectively.

The general development of the achieved charter hire rates follows the trend of the recent weeks and will most likely continue further sideways during the forthcoming weeks when the traditional summer lull period will reach its annual peak.

Whilst the market might experience here and there some occasional amplitudes for extra loaders, dry-docking replacements or other sudden and unexpected requirements, a general change in the trend shall be expected only after the majority of the market participants finished holidays.
