
The New ConTex Index has continued to recover recent lost ground although the pace has slowed with the Index gaining a more modest two points since last week.

The pattern of most sizes experiencing further rate rises has continued with the 4250 TEUs sector once again benefitting from the scarcity of larger ships and has been marked up 1.7% over last week basis 12 months and 1.3% higher basis 24 months.

Indeed the only size to experience a small downward adjustment is the 2500 TEUs segments but even this was negligible.

Owners can draw comfort from the fact that, as we progress further into September with most back at their desks and the doubtless increase in charter requirements, the unusually short list of available tonnage to the market heralds further rate rises in the near future.
