New ConTex-Commentary - issued:

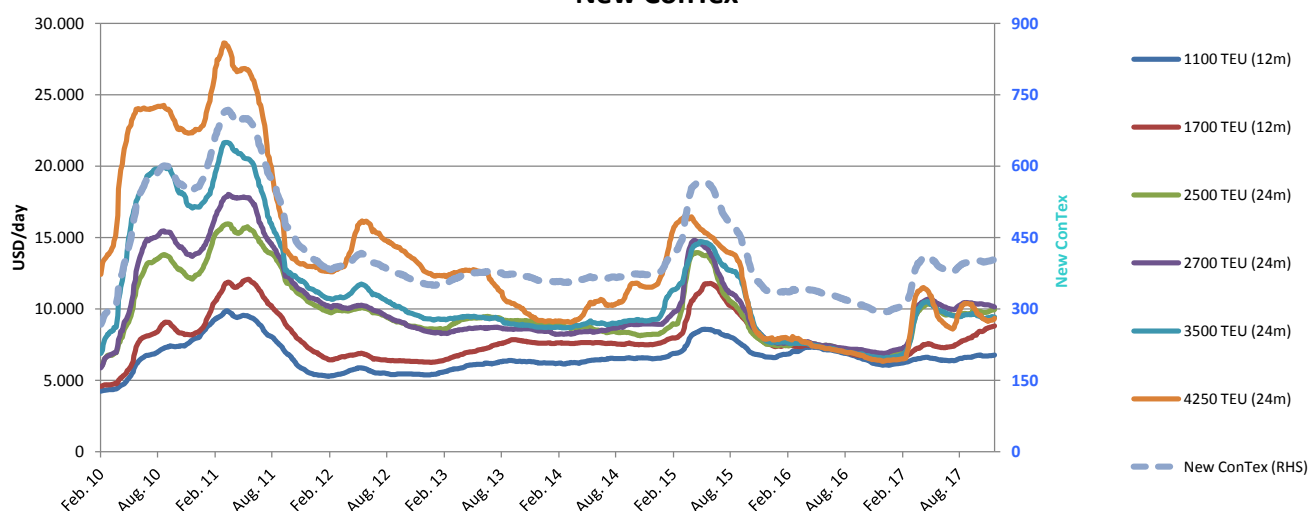

The New ConTex index has remained unchanged since last week, ceasing with 403 points at a level we have last seen in May 2017. While vessel segments between 1,100 TEU and 2,700 TEU could achieve slight improvements less than 0.5 % in their individual sub-indices, the classical Panamax types in the 4,250 TEU increased by 1.2 in the week-on-week comparison. The 2,700 TEU and 3,500 TEU segment have fallen slightly by -0.7% and -0.2% respectively within last week. The ConTex has increased by 4 points (1.0%) month-on-months. The 1,700 TEU segment played the mayor role with an increase by USD 256 (3.0%). Only the 2,500 TEU segment experienced a loss in the 24 month ahead by -1.5%. On an year-on-year comparison the ConTex increased by remarkable 108 points (36.6%) on basis of December 2016. As a result, 2017 paints a brighter picture as last year's development.
