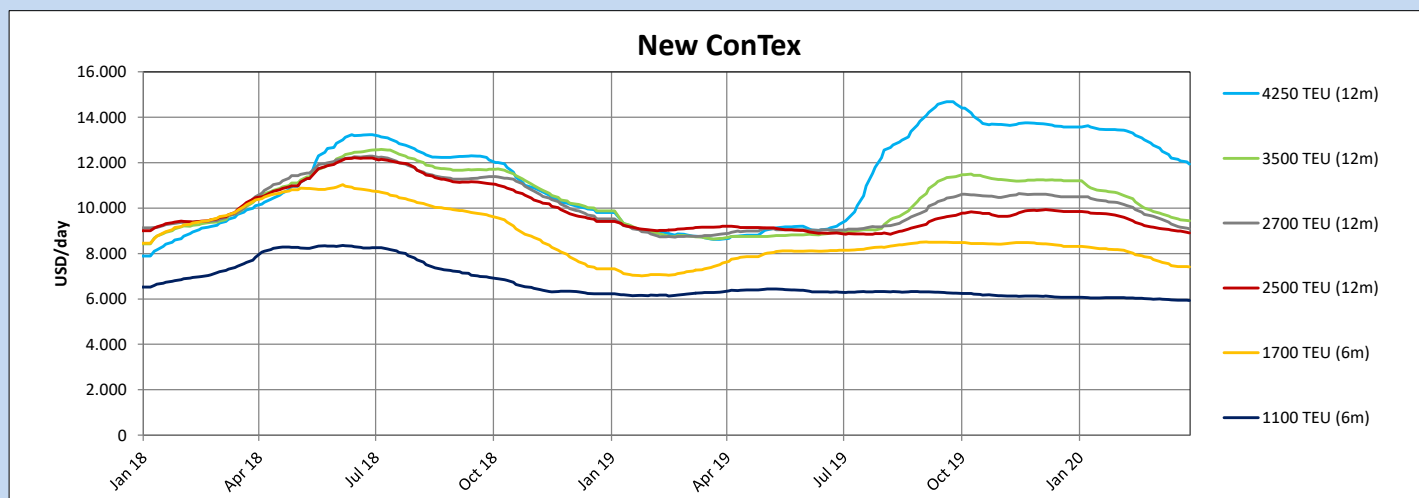

<p>Dear friends and business partners; the Covid-19 scenario has now started to have a stranglehold over Europe as well and is having a huge impact on all our daily lives. While the situation in most of the Asian countries seems to stabilize, the setting in Europe is getting harsher. During the last days, we noticed an increase in charter activity which we do regard as a good sign. Rate levels in most of the segments are moving sideways or even on a slightly negative tone. Except for the gearless 2700 TEU segment. This trend is underlined by the Context rate assessment which registers losses on all segments, although only marginal ones. The 4250's closing at USD 11.940 which is USD 130 less week on week. But worth mentioning its about USD 3300 per day higher compared to last year, when USD 8.619 have been assessed. The other segments hovering around last done levels with decreases around 0,2 and 1,0% on a week on week basis. Let's try to keep a positive momentum and most importantly stay healthy.</p>
