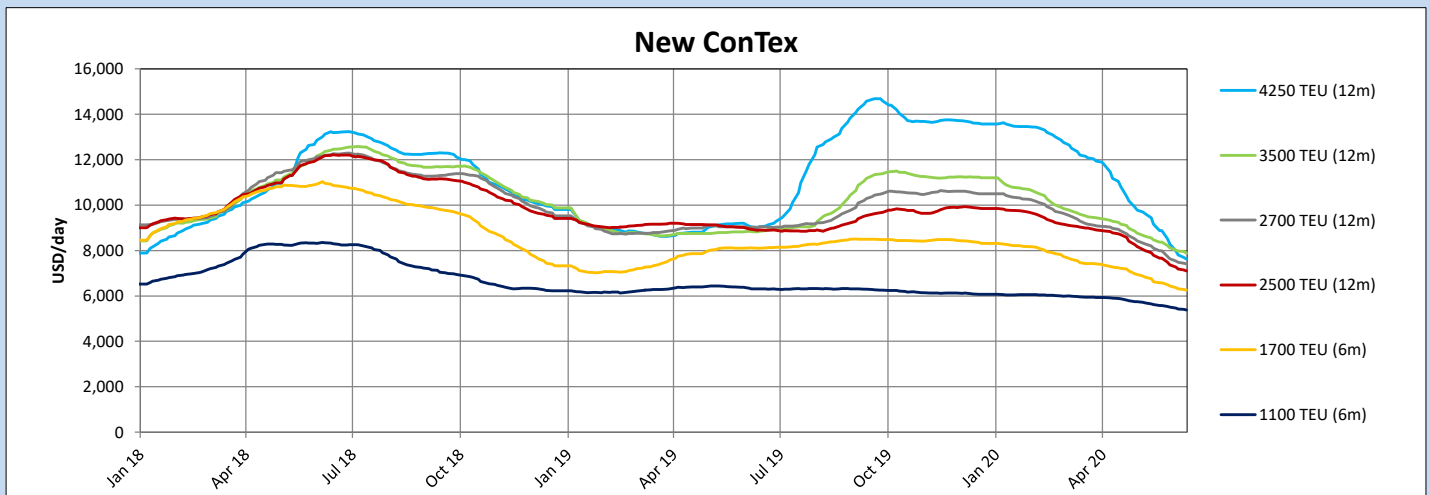

New ConTex-Commentary - issued:	11.06.20
<p>The Container Charter Market has again been quite busy with a number of fixtures concluded especially in the feeder segments.</p> <p>However, the 'strong' fixing activity has so far not been sufficient enough to reduce the overcapacity which remains high in many segments and keeping the charter rates under pressure.</p> <p>For the time being the New ConTex lost 4 points or 1,3% on the week to week basis down to 313 points with the 5700 TEU and 6500 TEU segments going down 4.1% respectively 5.3% and on monthly basis even 19,7% resp. 21.6% being the so called 'biggest looser'.</p> <p>Otherwise there has been some good activity in fixing which however sofar having no positiv effect on the market development with vessel sizes of 2500 TEU loosing 1,2%, 2700 TEU loosing 1,0%, 3500 TEU loosing 1,4% and 4250 TEU loosing 2,5% always basis 12 month period.</p> <p>The 1700 TEU and 1100 TEU segments just moving down by only 0,8% resp. 0,9%.</p> <p>The further developments have to be seen depending however entirely on the downsizing of the overhanged tonnage.</p>
