
New ConTex-Commentary - issued:	27.05.21

The New ConTex increased by another 38 points this week. Due to the continuous scarcity of tonnage across all segments, Month-on-Month figures are all up between 10% and 19%. The lack of supply is very obvious, particularly for the larger sizes as there are hardly any vessels available above 4,000 TEU. Larger vessels for example are already in discussion for Q3 2021 positions and post panamaxes even for 2022. Most segments also have low activity due to the scarce availability.

Looking at the Year-on-Year numbers, the New Contex is up by incredible 344% compared to May 2020. The biggest jump has been made by the baby panamaxes which gained almost 500% while the smaller segments are trailing a bit behind. However, these smaller segments, particularly the 1700 TEU vessels, are catching up quickly now as you can see at their Month-on-Month figures which are the highest of all segments.

There is no end in sight for this current bull-run as container freight rates continue to increase on most trade lanes and availability of ships to remain very limited for the foreseeable future.
