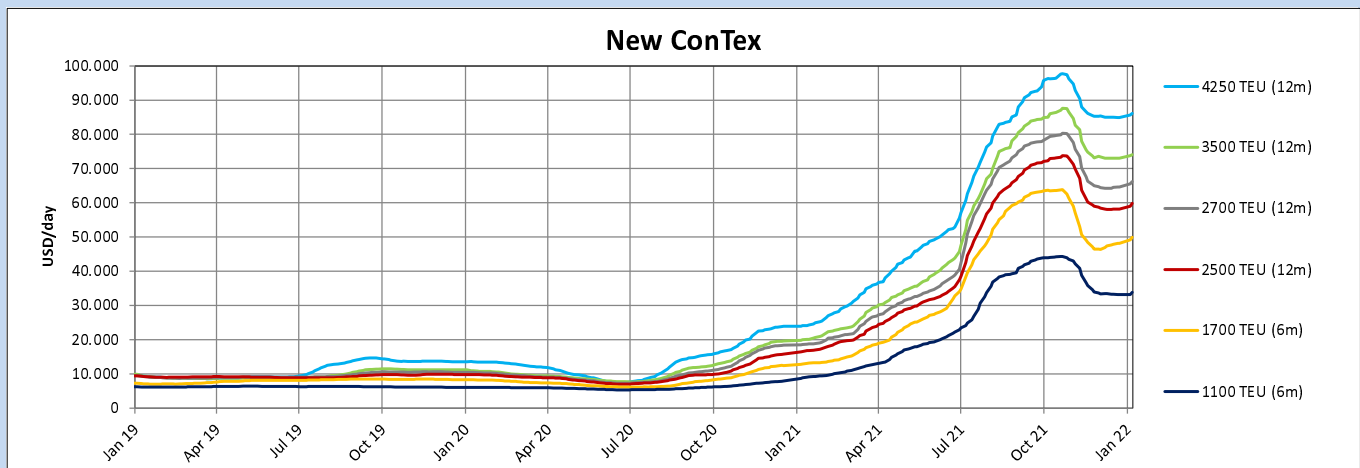

New ConTex-Commentary - issued:	06.01.22
<p>Happy New Year to you all and let's hope for some healthy and interesting 2022! The year started slowly as usual due to ongoing vacations but the tendency and demand remain positive which illustrated on the latest New ConTex figures & curves on all segments. Obviously the amount of open positions is unchanged limited and the owners are able to maintain their positions/terms in respect of period or rate levels.</p> <p>The New ConTex is now at 2673 points which is +59 up respectively +2,9% compared to the last report dated 21st December 2021. Going into excel sheet week-on-week comparison it is notable that all sizes have seen an increase like 0,8% increase for the 1100 TEU / 12 month valuation upto 4,6% (2500 TEU nominal, 24 months valuation) . If we compare the month-on-month the most positive trend is seen on the 1700 TEU segment with an upward development of 6,3%/5,7% for 6 months respectively 12 months.</p> <p>It will be interesting to see how the market/ConTex will develop during the next weeks before Chinese New Year – we wish you a good start and success in 2022 !</p>
