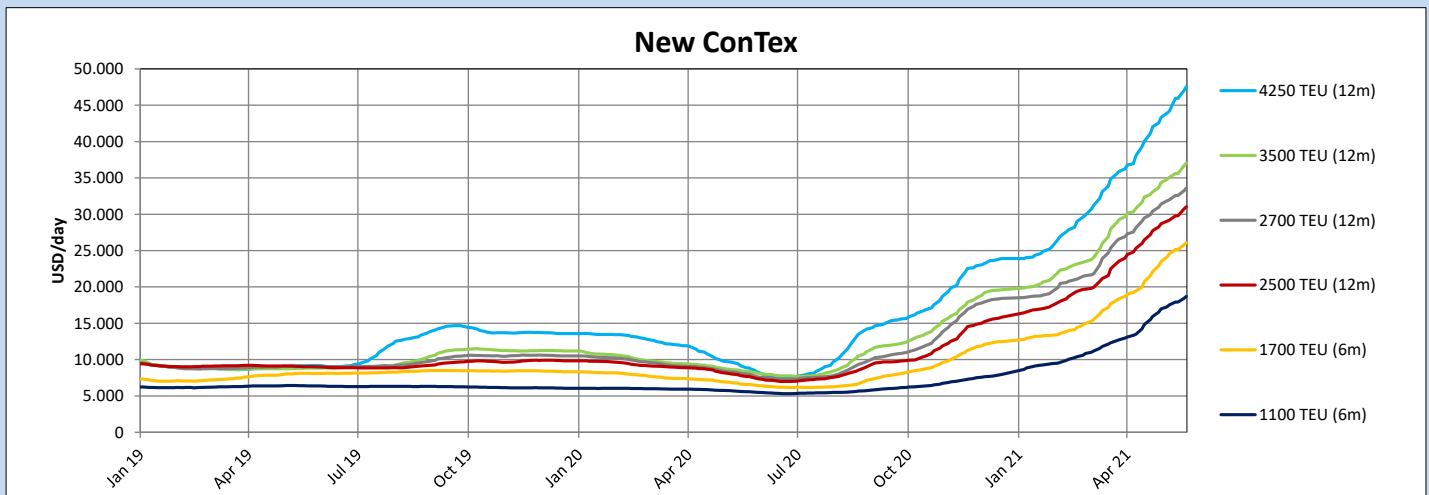

New ConTex-Commentary - issued:	20.05.21
<p>For close to a year we have seen a market moving only upwards, where only the sky seems to be the limit. We've seen a surge of The New ConTex moving up another 3,9% this week, higher than the previous week of 2,3%. On a monthly basis up 16%, while at 1402 points the Year-to Year increase is at a staggering 317,3%. The increase was seen throughout the segments, ranging from the lower end of 3,1%, while the largest increase was seen on the 1700's on 12 months seeing 4,5% increase. Compared to previous months the upward trend seems to have stabilized with an overall increase throughout the segments of between 2-5%. With the lack of prompt tonnage, operators are moving to secure forward tonnage in all size segments on a more regular basis, thus there seems to be no sign of any softening for the rest of the year.</p>
