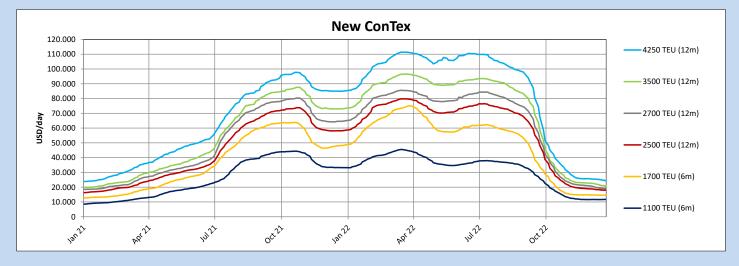

The New ConTex again lost 18 points / - 2.2 pct on a week to week basis and – 70 pct on year on year basis in fact the container charter market is ending 2022 in a very different mood from the euphoria of last year, at the same time. The severe market downturn of the middle of the year has taken its toll on charter rates which are today, on average, two-to-four times below their December 2021 level and even lower than that if compared to the historic rates reached in March 2022.

More than a correction, the market has suffered a proper crash, although it has come off from exceptionally high levels, entirely driven by the unprecedented Covid pandemic-related cargo boom.

Although the charter market has clearly fallen off a cliff and to not only optimistic but also realist today's charter rates remain twice as high as at the onset of the Covid pandemic. They are also, on average, much higher than during most of the 12 years preceding Covid. We would like to point out that there are only few containers vessels spot looking for employment compared to aroud 75 ships in spot position back in december 2019.
