

New ConTex-Commentary - issued:	20.04.23

This week continues to see positive trends which are reflected in the ConTex developments seen below, where all arrows are pointing upwards between 1-6%. The overall activity seemed to be present, especially in the 3500TEU and 4250TEU segments where 24 months has become the standard period and ships are fixed as soon as redelivery notices are tendered. The main liners are spear heading the demand, with CMA CGM leading the charge. This has caused the tier II/III operators to take a back seat for the time being.

The context experienced an overall 2.5% increase on a week to week basis, but clearly the largest segments are seeing the biggest spikes. The 4250TEU have the biggest increase, especially on 24 months, over 20% in comparison to last month. The 1100TEU saw the smallest change, where the market also seems to have stabilized over the past few weeks. Naturally the Year-on-Year is massively down from the historic rates we experienced in the first half of 2022. The lack of prompt tonnage is limiting the amount of fixtures being reported, however with availability increasing in second half 2023 this will likely change. Although there are mixed emotions for the remainder of the year, the short term expectations will be for arrows to remain steady upwards.
