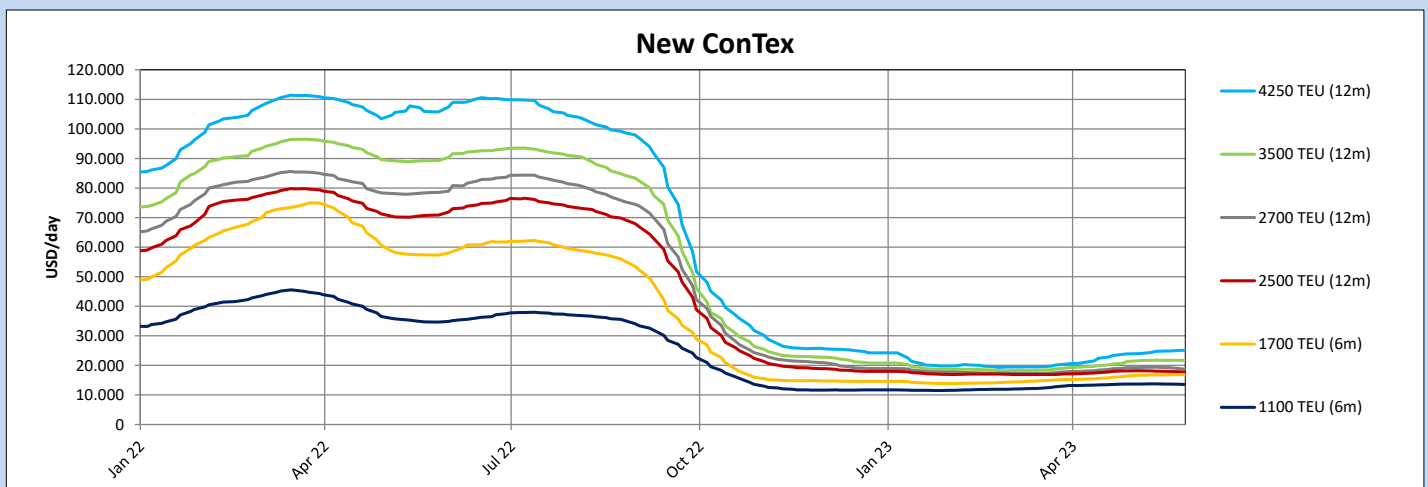

New ConTex-Commentary - issued: 25.05.23

Spring arrived with still some mixed temperatures which is somehow shown on the latest container market development / index valuations as well. Most of the segments moving sideways with very small changes. Compared to last week New ConTex where we had 0,7% up we see it now 0,6% down. When going through the segments on the week-on-week we see the highest up on the 5700 teu with 2,9% . The 2700 TEU / 12 mos showing -2,4% which is most negative difference. On the month-on-month we noted most positive trends for the segments from 3500 TEU upto 6500 TEU. Also 1700 TEU has seen an up of 4,2% respectively 3,5% for 12/24 months timecharter. It will be interesting to see if the trends will stay upto or as well during Summer 2023.
