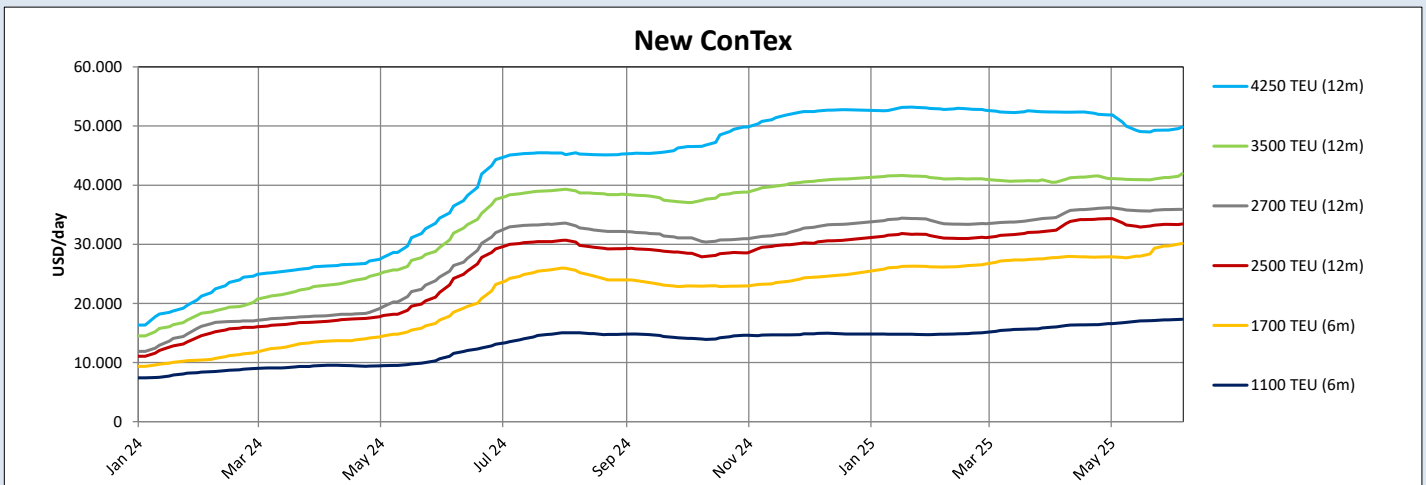

New ConTex-Commentary - issued:		05.06.25
<p>An active week is coming to an end with quite a number of fixtures concluded. However, the New ConTex does not really reflect this. We do notice a sideways movement in basically all segments with only a very, very small decrease of the 6500 TEU figures (\$91, respectively 0.1%) which is more or less attributed to a non-availability of open tonnage. In this segment forward fixtures for the end of this year and Q1/2026 are rather the rule than the exception. For Panmaxes and Sub-Panmaxes Owners are still able to take advantage of the increased capacity demand by charterers. Small(er) units are as well being fixed with a good balance of supply and demand, illustrated by only marginal (but positive) changes, regardless of their trading areas. The New ConTex stands at 1500 points now - the highest figure in over two and a half years.</p>
